We were hit by the Covid very badly because we were largely into Dentistry & Food and Beverages but over the last one year. We have fairly recovered as you see the company's become profitable, its come back to the bloom, as a half year ended September 22, we had a total income of 186.80 lakhs with a profit after tax of 12.74 lakhs.

Last quarter, the previous quarter, we have been able to continue the growth story where we have moved our Income from 62.63 lakhs to 79.75 lakhs to 107.05 lakhs for the previous quarters.

Over the last 3 quarters our bottom lines have been moving. We expect that the growth will continue as we move towards the end of this current financial year.
