
महापालिका भ्रष्टाचारमुक्त होऊ दे रे म्हाराजा...!

धामधूम असेल. यामुळे येणारे ११ दिवस हे मुंबई महापालिकेसाठी ताणाचे व आव्हानत्मक असतील हे मात्र नक्की. त्याचबरोबर 'श्रीगणेशा'चे विसर्जन करण्यासाठी कृतिम तलाव निर्मिति करण्याबरोबरच समुद्र किनारी तलाव, विहीरीत आदी ठिकाणी उत्तम व्यवस्था देण्याचे आव्हान पालिकेसमोर आहे. उंच गणेश मूर्ती हे नेहमीच उत्सवकाळात मुंबईचे आकर्षण राहिले आहे. राज्यासह देशातून मुंबईत गणेश मुर्त्या पाहण्यासाठी व दर्शनासाठी भक्तगणाच्या रांगा लागतात. याबाबत पालिकेला कल्पना असून देखील रस्त्यांवरील खड्डे भरण्याबाबत कोणत्याही प्रकारचे नियोजन उत्सव तोंडावर आला तरी पालिकेने केलेले नाही. यापूर्वीचे खड्डे भरण्यासाठीचे तंत्रज्ञान अपयशी ठरल्याने आणि कोट्यवधी प्रमाणात पैसा खर्च झाला. यानंतर पालिकेला जाग आली आणि ऑस्ट्रेलियाचे 'मिडास टच' हे तंत्रज्ञान आणण्याची नामुष्की ओढविली. हे तंत्रज्ञान नविन असले तरी त्याचा मुंबईतील रस्त्यांवरील खड्डयांवर कितीसा प्रभाव पडेल हे आता सांगता येणे कठीणच आहे.

दरवर्षी साजरा होणाऱ्या गणेशोत्सवा प्रमाणे विसर्जनाचे नियोजन पालिका निर्विघ्नपणे पार पाडते. यावेळीही गणेशोत्सव मंडळाच्या विसर्जन मार्गातील खड्डे मोठी डोकेदुखी ठरणार आहे. दरवर्षीच्या नियोजनप्रमाणे बाप्पाच्या विसर्जनाचे व्यवस्थापन करणे पालिकेला सोपे जाईल. पण केवळ चौपाटी. तलावांवर विसर्जनाचे नियोजन करून चालणार नाही. तर शहरातील अंतर्गत व्यवस्थापन उत्तम करण्याची गरज आहे. याचबरोबर विसर्जनाच्या दिवशी मुसळधार पाऊस पडल्यास आणि रस्त्यांवरील खड्डयात पाणी साचल्यास पालिका काय उपाय करणार किंवा गणेश भक्तांनी कशाप्रकारे काळजी घ्यावी याबाबत कोणतीही माहिती पालिकेच्यावतीने अद्याप तरी मंडळाना देण्यात आलेली नाही. निदान ज्याठिकाणी खड्डे पडले आहेत तेथे उपाययोजना करता न आल्यास 'या ठिकाणी खड्डा आहे तरी मंडळांनी गणेशमूर्ती सावकाश न्याव्यात' असे दिशादर्शक फलक लावण्याची गरज आहे. परंतु, पालिकेला जाग येण्यासाठी काहीतरी घडावे लागते हे १०० टक्के सत्य असल्यानेच प्रशासनाने अद्याप नियोजन केलेले नाही, असे खेदाने म्हणावे लागते.
